WELCOME

For Byounique Trust, 2016 was a hectic, inspiring and exciting year! We extended from 2 to 4 offices and from 6 to 11 team members. We started innovative new projects and we reached out to a still growing number of beneficiaries. Being a partner in the Unicef National Diversion project offered opportunities to strengthen our partnership-network and to regularly share ideas about how to achieve our final goal: to create a truly accessible, lawful and child-friendly child justice system in Malawi.

Our expansion pushed us to further professionalize our teams, our policies and procedures and our impact-measurement. As a result, by end 2016, Byounique had developed into a goal-oriented organization with highly qualified and motivated team members who are able to plan, implement and fully account for the projects in their respective areas. On management level, the program manager could focus more on monitoring and evaluation, representing Byounique and improving projects and teams, through individual and team trainings.

End of 2016, we set our ambitious goals for 2017. Cordaid and Unicef had given specific funding for our 2016 (diversion) projects. We knew that the ending of these 2 mayor donors would pose a challenge for our 2017 budget. We decided to restructure teams and adjust project structures, and this way still continue in our 4 towns and with our complete activity program, knowing that the projects complement and strengthen each others impact. Our goal was to secure the remaining funding for our complete 2017 program by the end of April 2017 and use the remainder of 2017 to find funding for our 2018 projects.

The main focus will be to further embed our projects within existing structures, both government and locally. This will guarantee the long-term sustainability of our projects and will offer the chance Byounique to withdraw from active implementation to offering support. This will enable us to venture into new projects or areas, where there is again need for our expertise.

We realise that we can only achieve these ambitions with the support of our loyal and new donors. Our current financial challenge only motivates us to work even harder. On daily basis we see the essential impact for our projects and the need to continue our work. We trust that our visibly impactful successes on the ground and our relentless efforts, will inspire donors to support our work and to be essential in achieving live-changing opportunities for our vulnerable, unique beneficiaries!

SUMMARY 2016

Our dream

All vulnerable children in Malawi have the opportunity to build up a good future

Our impact

We aim to prevent that children come into conflict with the law by tackling the underlying problems and reasons for child crime. Working with children, families and communities we achieve that society members identify and support vulnerable children in the earliest stages. As such, problems are solved and the children regain their positive lives. Identifying and supporting the children is done by community members, schools and professionals, stimulated by a strong feeling of joint responsibility for the well-being of children in Malawi.

Our approach

We implement a coherent program of projects aimed at prevention, rehabilitation and awareness building. All project strengthen each others impact. Prevention results in less children coming into conflict with the law. And that children who do, are treated lawfully and child-friendly: children stay shortest, are least traumatized and focus is on reintegration into family/community. Alternative sentences (diversion) teach children on positive behaviour change, while staying and contributing positively to their communities. Lower number of children in institutions makes it feasible to offer their basic needs and proper rehabilitation programs. Awareness building creates a broad sense of joint responsibility and acceptance of released children, so communities welcome them and give them a stable place in society.

Our results

Our projects lead to positive behaviour change with children, increased parental skills with caretakers and within schools, empowerment and resilience of families and communities, lawful treatment of children by child justice professionals, employment and entrepreneurship opportunities for youths and broad knowledge on child rights and the rights of children within the child justice system with professionals and within the Malawian society at large.

In doing this, we step by step create a child justice system in Malawi that is lawful and accessible to all children and that aims at prevention and rehabilitation. Because each child always deserves a second change to a good future.

Every day, we give our 110% effort to achieve that every child in Malawi gets the chance to build up a good future. Our beautiful results on the ground continuously give us new energy and motivation

HIGHLIGHTS 2016

Child Rights Clubs

We implemented Child Rights Clubs in 44 schools, educating over 1.500 children, teachers and parents on child rights & child justice. We empower them to avoid abuse and maltreatment and we create Child-Friendly schools supporting vulnerable children.

Theatre-prevention

We trained 78 'troublemakers' in their communities in positive behaviour and family amendment. They became strong actors and the groups did 14 performances in their communities, educating the people about prevention of child crime and making child crime prevention plans in the communities.

Legal support to children at police, courts and prisons

Our bail project for youth who have been on remand for years in Mikuyu and Bvumbwe is highly successful. Of 14 applications, 11 boys were released/granted bail, 3 cases are still pending. Our daily visits to police stations result in faster processing of cases and more diversion referrals.

Diversion

As partner in a national diversion project supported by Unicef and Child Justice Forum, we extended our diversion project to Mangochi and Chikwawa/Nchalo. We successfully diverted 177 children, held 15 outreaches in communities, 15 activities in schools and achieved broad support for diversion as an effective child justice measure.

Rehabilitation

Apart from Mikuyu and Bvumbwe, we extended our rehabilitation programs to Chikwawa and Mangochi prisons, still focussing on young offenders, up to 22 years. We reintegrated 142 boys back into their communities, trained 77 in vocational and entrepreneurship skills and held 11 Civic Educations. We offered extra support fixing the Mikuyu roof, the Bvumbwe kitchen, bringing clothes, medication, soap and transport money for the boys to reach home. Over 94% of the reintegrated boys does not reoffend.







HIGHLIGHTS 2016

School support

We now support 50 children who have successfully reformed via Byounique counselling programs, in primary and secondary schools, with fees, uniforms and materials. We regularly follow up on their performance and behaviour with the schools and families.

Entrepreneurship support

Many of the youth that finalize our programs struggle to find employment. Best chances for them to earn an income is to start a business. But with often low school qualifications and tough competition on the markets, this is another challenge. Our entrepreneurship program gives released youth and youth groups from our high-risk communities better chances. In our 2016 pilot we trained 50 youth and supported 8 successful business start-ups.

Tisinthe child (justice) rights radio program

We successfully launched this radio project to inform youth, parents, community members and professionals on child rights, prevention of child crime and accepting reformed children back into the community. The program was aired for free by national and local radio stations. Via youth clubs we trained over 400 youths to become active Child Rights Ambassadors in their communities, signalling and solving child rights violations.

Outreach and presentations

Apart from outreach activities via theatre and diversion, our radio listeners groups did 15 outreach activities in their communities, targeting challenges & solutions in those areas. With our professional Byounique theatre groups we further did 16 outreach activities in schools and high-risk communities. As a result, community members visit our offices frequently to denounce violations of child rights and ask for support.

(Social) Media

Newspapers, magazines and radio often cover Byounique activities or give broad information on our work. The Nation for example covered our Child Rights Clubs and the *Tisinthe* radio program. This way our brand awareness increased, which helped us to extend the impact of our work in Malawi.







ORGANIZATION

byounique trust

Byounique Trust was founded in December 2011. In 2013 it was officially registered as a Malawian NGO. Byounique Trust is governed by a Board of Trustees, consisting of 5 volunteer board members, and a management team. The Byounique head office is based in Zomba.

mission

Ensure that children and young persons in conflict with the law are treated well, according to the rules set out in (inter-)national Covenants, Agreements and Constitutions and are offered a chance for a good future.

vision

All children have the right to develop their personal, unique skills and qualities which will enable them to have a good future and to contribute in a positive way to the society they live in.

our target group and focus areas

The organization's target group in Malawi are children in conflict with the law, aged 10-22. Ten (10) is the age at which children in Malawi are held criminally responsible and can be arrested and tried.

We specifically include children aged 18-22 in our projects. This is the age range of the boys in the young offenders prisons, as well as an important age range for vulnerable youths. As these youths are on the bridge to adulthood, we support them in Life Skills and in making good decisions. The right support at this age can mean the vital difference between (re-) offending or building up a prosperous future.

the team in Malawi

In 2016, Byounique had 4 offices, in Zomba, Blantyre, Mangochi and Chikwawa/Nchalo. The complete Malawi team consisted of 11 trained Malawian social workers, 2 internship students, 25 volunteers/facilitators and 1 Dutch program manager.

The program manager is in Malawi about 9 months a year to monitor and support the projects on the ground. The other months of the year she travels to the Netherlands for board meetings and fundraising activities. During those months she is in direct contact with the team in Malawi through internet and WhatsApp.

byounique in the Netherlands

Byounique Trust is supported by a team in the Netherlands, consisting of 3 volunteer board members and 2 volunteers offering practical support. The main activities of the Dutch team are supporting the team in Malawi and raising funds for the activities in Malawi.

PREVENTION

child rights clubs in schools

This project aims to prevent violations of child rights and to prevent children from coming into conflict with the law. Via workshops and school activities, we teach children about their rights, responsibilities and prevention of child crime. We train teachers to become in-school-social-workers: to identify children at risk and offer support themselves or call in support. We empower children to become Child Rights Ambassadors in their schools. We actively involve parents and reach out to the communities surrounding the schools to prevent child crime risk factors.

theatre child crime prevention project in high risk areas

The theatre project targets children that are at risk of getting into conflict with the law: those that have dropped from school and are idle, with family problems or who are already making problems in the community. These children work on positive personal change by attending weekly theatre workshops. They inform their peers and community members about the risk factors and the ways to prevent child crime by giving theatre shows on child crime prevention in their communities. An essential part of the project is to involve community members in actively preventing child crime by making community child crime prevention plans that communities implement themselves.

legal support to children at police, court and prison

The rights of children in conflict with the law in Malawi are violated on a daily basis, at police, courts and in the reformation facilities (reformatory centres and young offenders prisons). Lack of knowledge and means to claim their rights and lack of litigation are main reasons for these violations. We disperse broad knowledge on child justice rights, offer concrete legal support, and reach out to lawyers and law students to support us in guaranteeing the rights of these children.

capacity building and knowledge exchange

An important reason why the rights of children in conflict with the law in Malawi are violated is lack of knowledge with the main stakeholders. This also leads to continued old-fashioned mentalities of punishment and retribution. Byounique trains police, judiciary and young offenders' prisons staff on child rights, child justice rights and also specific topics, like diversion. We organize quarterly meetings with all stakeholders to discuss challenges and solutions and to strengthen partnerships.



REHABILITATION

diversion projects

Diversion means channelling cases away from the criminal child justice system. It is an essential alternative to sending first, small offenders to institutions and it offers many benefits to children, parents, victims and community members. Byounique is a strong promotor of diversion. Our programs focus on teaching Life Skills, amending the relationship with families and communities, repairing the harm to the victim and making the child set positive goals in life. The programs include outreach activities at schools and communities and trainings of child justice practitioners.

rehabilitation projects to young offenders in prisons

The goal of this program is to prevent young offenders from reoffending, by making a positive plan for life after release. The young offenders are counselled individually and in groups and receive family amendment. To give them possibilities to find a job or start a business, all young offenders participate in the Byounique vocational skills training and entrepreneurship trainings. Byounique follows up on them after their release About 94% does not reoffend, but builds up a good life.

supporting children with school fees

Education is an essential factor for personal development. In our projects we meet many children who are motivated to go to school, but their families cannot support this. Therefore we financially support rehabilitated children to go to school, primary or secondary. The support includes school fees, school uniforms, school materials and exam fees. We monitor the progress of each child in school and we involve the parents to support their children and contact us in case of challenges.

entrepreneurship support

With a youth unemployment of over 70%, our reformed youths encounter many challenges to find employment after finishing our programs. Best chances for them to earn an income is to start a business. We offer support via after-release business training, assistance to make a business plan and motivation to continue despite challenges. We combine this program with offering youth entrepreneurship trainings in the high-risk communities where our reformed youths reside.







AWARENESS BUILDING

Byounique child justice award

We award the Byounique Child Justice Award to a young person who has committed him/herself in a unique way to child justice. Young persons can broadly showcase their activities and motivate and inspire others to support children in conflict with the law, while we learn about innovative projects and can find chances to support those with high potential to achieve more impact for children.

Tisinthe child rights radio program

Tisinthe is a 14-weeks radio drama program that tells the story of a boy who gets into conflict with the law, but then successfully rehabilitates. In this captivating way, we educate the audience about prevention of child crime, child justice and accepting reformed youth. Youth listeners clubs support the program with community activities and becoming Child Rights Ambassadors.

outreach activities in high-risk areas

Our outreach activities educate and motivate children, caretakers and community members to take active responsibility in prevention of child crime, ensuring the rights of children in conflict with the law, accepting diversion as a best child crime consequence and receiving reformed boys & girls back into their communities.

presentations on child rights and child justice system

Individuals and organizations often do not realise how much they can mean for children in need. Even by showing an interest, the children feel more accepted and part of their community, which is essential to their motivation to change. With our presentations we give theoretical information and practical examples on how people can offer support, directly or through Byounique.

media attention

To make lasting changes in the Malawian Child Justice System we need the support of Malawian citizens to acknowledge these rights and to demand that main stakeholders to uphold these rights. Therefore we make the public aware of the violations of child justice rights and the ways in which they can help to improve this situation. We inform the public through various kinds of media like radio, newspaper, website or Facebook.







OUR PROJECTS IN MALAWI: RESULTS 2016



organization

In 2016, Byounique Trust further strengthened its organization in Malawi. Next to Zomba and Blantyre, we opened 2 new offices, in Mangochi and Chikwawa/Nchalo. Our team extended to 11 full-time social workers, 2 interns and some 25 volunteers, monitored and supported by our program manager. Our projects cover Southern, Eastern and Central regions, combined with some national programs. We actively network with our partners in the North to allign projects and exchange information. We invested much in training the new teams in the Byounique structures, policies and values. By end 2016, all 4 teams were able to work goal-oriented and effectively while being fully accountable for their work.

projects

We continued to improve our projects on planning, implementation and impact-evaluation. We started new projects like entrepreneurship trainings for youth in communities and for released prison youth and the Tisinthe radio program. With these projects, we supported yet a larger number of beneficiaries, in towns, more remote areas and with national coverage. As we invest much in embedding our projects within existing, local structures, our projects gain growing sustainable impact.

fundraising

In 2016, for the first year since our start in Malawi, our spending exceeded our income. Compared to previous years, we received less and smaller donations. The Unicef-funding was only for 1 year and in the Netherlands, several donors chose to prioritise local projects, instead of international organizations. By end 2016, we had not yet acquired the amount needed for our full program in 2017. We set the goal to secure the remaining funding by April 2017 and to use the remainder of 2017 to secure funding for our 2018 projects.

2016 in figures: PREVENTION

Child Rights Clubs in schools:

- Improved our 12-weeks workshop program
- Trained 9 more facilitators to implement the project, making a total of 12
- 44 participating schools: in total trained about 1.250 children, 100 teachers, 800 parents
- Through school activities imparted knowledge about child rights to over 8.000 children
- Short programs in 6 schools, training 168 children and 16 teachers on Child Rights
- Per school 1 teacher and 2 children trained to continue the Child Rights Clubs after the Byounique program ends as an embedded part of the school curriculum
- Grand final activities in the schools with headmasters and teachers, parents/caretakers and of course all child participants and learners

Theatre-child-crime-prevention project:

- 78 children have successfully finalized the project
- 14 performances in high-risk areas, reaching out to at least 5.000 community members
- Child-crime-prevention plans in 9 communities
- Follow up meetings planned in all 14 high-risk areas to further implement the child-crimeprevention plans

Legal support to children at police and courts

- Followed up on about 280 child cases from arrest to finalizing their cases
- Information and support to parents/caretakers of about 120 children
- 6 meetings with all stakeholders, to improve the child justice processes on the ground
- Practical support like mediation sessions, bringing children home or doing home assessments
- Change of mentality at police, court and partners to ensure child (justice) rights







Prevent that children commit offences and ensure that children at police, court and child justice institutions are treated lawfully and child-friendly

2016 in figures: PREVENTION

Legal support to young offenders at Mikuyu, Bvumbwe, Chikwawa and Mangochi prisons

- Database of boys who have overstayed on remand, collecting all judicial information
- Contacting parents/relatives to visit these boys at the prisons and to offer mental support
- Follow up on their cases at police and court to ensure that cases are dealt with on shortest notice, within the legal time-frame
- Applied for bail/court hearing for 14 boys at Mikuyu and Bvumbwe who have long (for years) overstayed their remand period
- Successful full release of 2 boys, 9 bail awarded and 3 cases pending
- Building up strong partnerships with Chancellor College, Malawi Law Society, Legal Aid Bureau and law firms

Entrepreneurship trainings to youth in high-risk areas

- 50 vulnerable youths from high-risk areas and released boys from prison participated in entrepreneurship trainings
- 8 successful business start-ups individual and in groups

Capacity building child justice practitioners

- 4 police stations trained in child (justice) rights
- 4 trainings for child magistrate, social welfare, and representatives of police stations

LOOKING AHEAD

2016 marks our 5th year working in Malawi! We celebrate this anniversary and the successes we have achieved, while eagerly looking forward to the coming years. Our inspiration comes from our beneficiaries. They continuously visit our offices to explain how our support has changed their lives. Our inspiration comes from the spontaneous activities of police or prison staff, youth clubs or community members to support our work. And it comes from our donors, whose support enables us to achieve our live-changing successes.

Many projects that Byounique implements should ideally be implemented by government and local entities. During the last 5 years, Byounique has already made important steps to achieve this by changing mind-sets and procedures at police, judiciary, prisons and schools, also with lawyers, students and companies.

Our strategic plan 2017-2020 focusses on sustainability, resilience and exiting from direct project-implementation to monitoring and support. Our main objectives are to further embed our projects with (government) partners and to achieve necessary changes in national policies/procedures, finances and mind-sets. And to further embed our projects within local structures, like school curriculums, community crime prevention settings, youth clubs or prison rehabilitation structures. We will train key persons on methodology, financial management and income-generation. We will empower youth to become child rights Ambassadors and to take the lead into positive change. This approach to sustainably hand over activities is a logical next step to achieve our goals in the Child Justice System.

We are fully ready to continue working hard to achieve these goals for our vulnerable beneficiaries: 2017, here we come!
